## Notes:

Matches may begin 15 minutes early if all involved teams are available and agree.

Warm-ups: 2 minutes shared, followed by 4 minutes serving team, 4 minutes receiving team. (Serve within own 4 minutes.)

Coaches must second referee (R2).

Match is 2 out of 3 sets to 25 (deciding set to 15)


Missed referee assignment - 1 point p/minute beginning 5 minutes prior to scheduled match time. (Assesed on next set/match.)


1st place pool winners advance to championship brackets.


2nd and 3rd place pool finishers compete in consolation matches.

There are no tie-break sets. If 3 or more teams finish pool tied in match records, teams will be seeded by; 1)sets won/loss pct., 2)point percentage [Pts scored divided by pts scored against. The higher point percentage is the higher finisher, etc.] 3)Coin toss. All 2-team ties are decided by the head to head match in pool play.
