Coaches must second referee (R2).

Missed referee assignment - 1 point p/minute beginning 5 minutes prior to scheduled match time. (Assesed on next set/match.)

1st and 2nd place teams from pool play advance to the Championship Bracket.

There are no tie-breaks. If more than 2 teams finish pool tied for 1st (all 2-1), teams will be seeded by; 1)sets won/loss pct., 2)point percentage [pts scored divided by pts scored against]; 3)coin toss.
