Missed referee assignment - 1 point p/minute beginning 5 minutes prior to scheduled match time. (Assesed on next set/match.)

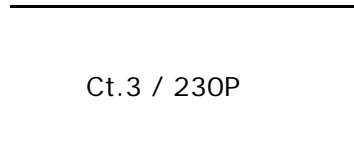

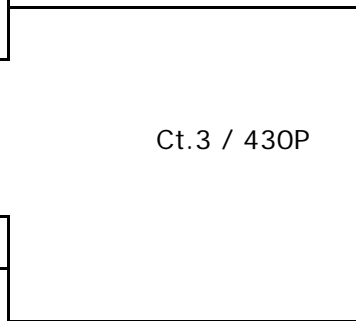
